LETTER TO THE COMMUNITY

On behalf of the young children and families who rely on us for critical mental health treatment, thank you for your continued support of The Children's Center Utah during the 2020-2021 fiscal year. It was another challenging year and we hope you and your loved ones remain well.

During those 12 months, our organization continued to provide services to advance our mission and mitigate the effects of the COVID-19 pandemic for families and children. In the next few pages, join us in reviewing our 2020-2021 organizational milestones and accomplishments.

During the pandemic, with children out of school and families often isolated at home, the importance of children's mental health has been at the forefront of conversations and in the headlines.

At The Children's Center Utah, we have long understood the critical importance of young children's mental health.

In 2020, with the support of community partners, we commissioned the Kem C. Gardner Policy Institute at the University of Utah to conduct an independent study on the status of early childhood mental health in Utah and its related systems. Titled *Early Childhood Mental Health in Utah*, the study found that there is a critical need for early childhood mental health services in Utah. National research shows Utah is among a group of states with the highest prevalence of child and adolescent mental health disorders and the highest prevalence of youth with untreated mental health needs.*

Because of the many additional difficulties faced by families, we saw an increased need for the specialized mental health services we provide, and during our 2020- 2021 fiscal year, we treated nearly 1,200 young Utah children and their families and caregivers. One way we know we can reach more children and families is to provide training to more providers of all types who work

with infants, toddlers, and preschoolers.

During the spring 2021 session of the Utah Legislature, as part of our advocacy for public policy in support of children's mental health, we worked with our stakeholders and the Utah State Legislature in support of H.B.337, Child Mental Health Amendments. This legislation passed unanimously, and expands training for early childhood providers throughout the state. By improving understanding of child mental health among early childhood providers in both rural and urban areas, this legislation ultimately gives children throughout the state greater access to the care they so desperately need.

Lastly, we are proud to announce an important addition of "Utah" to our name – The Children's Center Utah. This better reflects our expanding statewide services, and our growing impact on Utah children and their families.

We remain so grateful for your support, and we are so appreciative of your championing for, and commitment to, children in our communities. We look forward to working together so Utah children in need of mental health services will continue to hope, heal, and thrive.

CLINICAL SERVICES MILESTONES

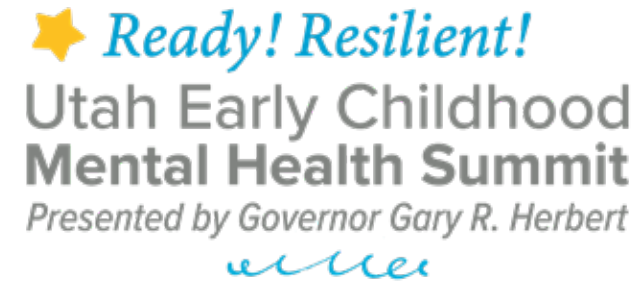
We are proud to be one of the only organizations in Utah with a large number of expert clinicians who are passionate about early childhood mental health. Our team embraces diversity and inclusiveness, providing vital therapeutic services to the children and families we serve. Their strengths and commitment allow us to continue to provide comprehensive mental health care to enhance the emotional well-being of infants, toddlers, preschoolers, and their families throughout the state.

- ✔ The national ZERO TO THREE Fellowship was awarded to Jennifer Mitchell, Vice President, Clinical Strategy and Innovation. We are proud to acknowledge that she joins a global network of diverse visionary leaders who have the expertise, skills, passion, and commitment to make the world a better place for infants and toddlers.
- ✔ The American Psychological Association Commission on Accreditation granted our Psychology Internship Program full accreditation. This has been a year-long process that will enable us to pull from a wide field of experienced internship applicants to further the amazing work of our Psychology Program.
- ✔ The National Infant Toddler Court Program awarded The Children’s Center Utah a grant to pilot the implementation of a Safe Babies Court Team in Utah County. This program aims to improve experiences of young children and families under court jurisdiction by utilizing developmentally-appropriate, sensitive responses to child maltreatment of infants and toddlers.
- ✔ With funding from the Utah Division of Substance Abuse and Mental Health, The Children’s Center Utah launched the Infant and Early Childhood Mental Health Teleconsultation Project. This project provides skilled instruction and support for early childhood providers throughout the state with a wide range of children’s mental health topics.



As with every year, our clinical team of nearly 40 professionals ensured our direct services focused squarely on our mission of providing hope and healing for the 1,200 children and families we serve. The milestones met this year fortify the strong infrastructure and continuum of services we offer.

READY! RESILIENT! UTAH EARLY CHILDHOOD MENTAL HEALTH SUMMIT



In 2020, The Children’s Center Utah commissioned a groundbreaking study titled *Early Childhood Mental Health in Utah*, conducted by the Kem C. Gardner Policy Institute at the University of Utah, that overviews Utah’s current children’s mental health system and uses Utah-specific data and information to analyze risk, reach, and potential return on investment in terms of children’s mental health in Utah.

The study creates a foundation for ongoing discussions about how to improve access to much-needed early childhood mental health services given varying risk factors and program distribution among different populations and regions throughout the state.

KEY TAKEAWAYS

- 🔑 Based on a range of estimates from national studies, 10-20% of Utah’s 458,000 children between the ages of 0-8 could experience mental, emotional, developmental, or behavioral challenges.
- 🔑 National cost estimates of mental, emotional, and behavioral disorders among youth are \$247 billion per year in mental health and health services, lost productivity, and crime (*Eisenberg and Neighbors, 2007*).

To present the findings of this study, The Children’s Center Utah, in partnership with Governor Gary Herbert, hosted the state’s first-ever summit on children’s mental health in Utah on October 5, 2020. Held virtually, the summit attracted 700 registrants throughout the state. In addition to participation by Governor Herbert, Lt. Governor Cox, and other state leaders, the summit included nationally-renowned experts in early childhood mental health, Dr. Nadine Burke Harris, MD, MPH, FAAP, and Dr. Mimi Graham, Ed.D.

This study was a collaborative effort and first step in raising awareness of the importance of children’s mental health, creating a common understanding and language around early childhood mental health, fostering understanding of mental health resources, and shaping the path for future-oriented solutions. From this study, we created a working group of professionals throughout the state to develop specific solutions and policy strategies for our state leadership. STATEWIDE IMPACT

The Children's Center Utah grew its state-wide expansion with a contract from the Office of Childcare for Early Childhood Consultation and Training effective through June 30, 2025.

The Early Childhood Consultation and Training team members work in Davis, Weber, Washington, Iron, Beaver, and Morgan counties.

Governor Spencer Cox declared May 20 as Children's Mental Health Awareness Day in Utah

In April, 2021, Governor Spencer J. Cox and Lt. Governor Diedre Henderson held a ceremonial bill signing at The Children's Center Utah that significantly increases access to mental health services to improve children's lives. Included in the signing was H.B.337 Child Mental Health Amendments, sponsored by Rep. Steve Eliason and co-sponsored by Senator Ann Millner.

THE IMPACT OF COVID-19

This was a year of great upheaval for many families. The ongoing anxiety, grief, stress, and uncertainty created by the COVID-19 pandemic has weighed on many of us, especially on young people and children who had experienced physical isolation, and are having a challenging time coping.

TELEHEALTH SERVICES

To meet the high need of our community, in April 2020 we pivoted our services and provided clinical outpatient services via telehealth. Gradually, we were able to provide hybrid services, to allow our most critical families to receive services in-person at our Salt Lake City location.

THERAPEUTIC SCHOOL PROGRAM

After a few months of being closed, we re-opened our Therapeutic Preschool Program in small, closed cohorts, with each classroom riding to and from the center together on their own bus. Temperature checks, increased

sanitization efforts, and masks became the norm to keep our families safe. We are grateful to have safely worked with our clients during this time, when children and families across our state experienced enormous adversity on top of existing challenges.

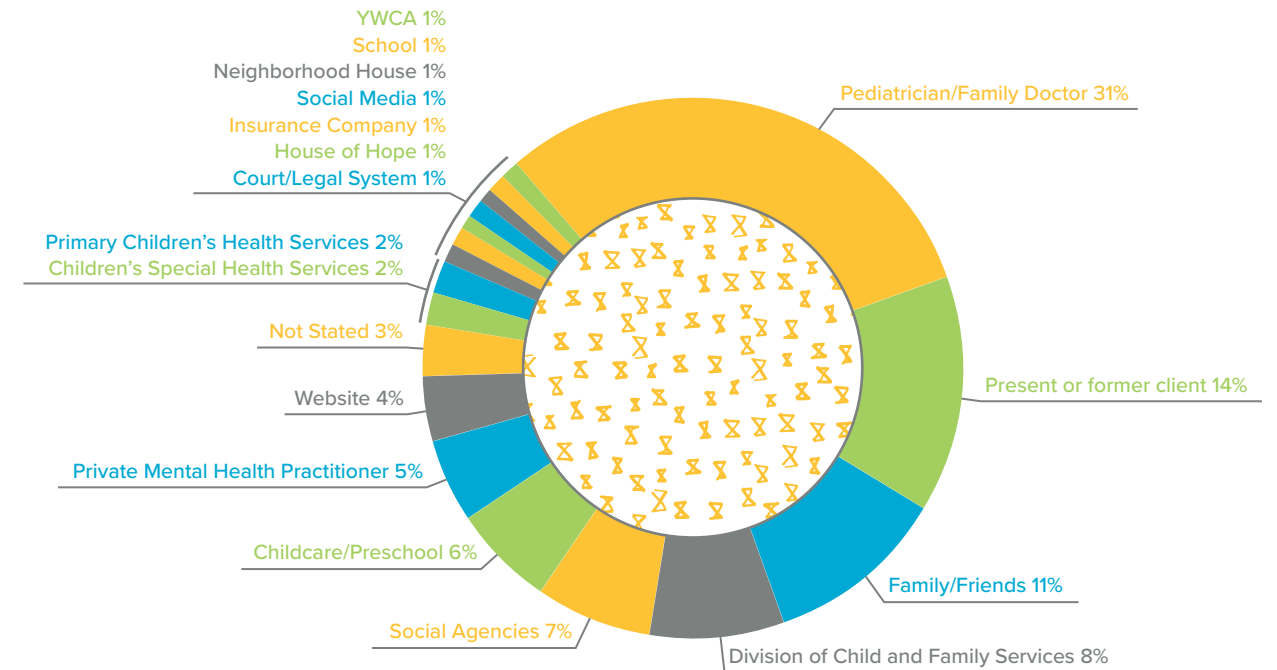
Before the pandemic, rates of childhood mental health concerns had been rising steadily. Now, well into the pandemic the increased stress and trauma continue to compound mental health concerns among children.

The next upcoming months will be crucial in the journey of identifying strategies to improve the access, prevention, and treatment of early childhood mental health care throughout the state. Increasing awareness in the community to help parents, physicians, pediatricians, clinicians, and caregivers understand the importance of early childhood mental health as part of development, will allow us to increase the support for clinical services and trauma-informed care.

EVIDENCE-BASED TREATMENT MODALITIES

ATTACHMENT AND BIOBEHAVIORAL CATCH-UP (ABC)

Evidence based, short term treatment focused on helping caregivers provide nurturing care and engage in sensitive interaction with their children. The ABC is a 10-week program that utilizes two models, Infant and Toddler, and provides services for children six months to four years old.

ATTACHMENT, REGULATION, AND COMPETENCY (ARC)

Adaptable intervention developed for children who have experienced complex trauma, along with their caregiving systems. Identifies and addresses important childhood skills and competencies which are routinely shown to be negatively affected by traumatic stress and by attachment disruptions.

CHILD-PARENT PSYCHOTHERAPY (CPP)

Treatment focuses on ways in which trauma has affected the parent-child relationship and the family's connection to their culture and cultural beliefs, spirituality, intergenerational transmission of trauma, historical trauma, immigration experiences, parenting practices, and traditional cultural values.

THE INCREDIBLE YEARS (IY)

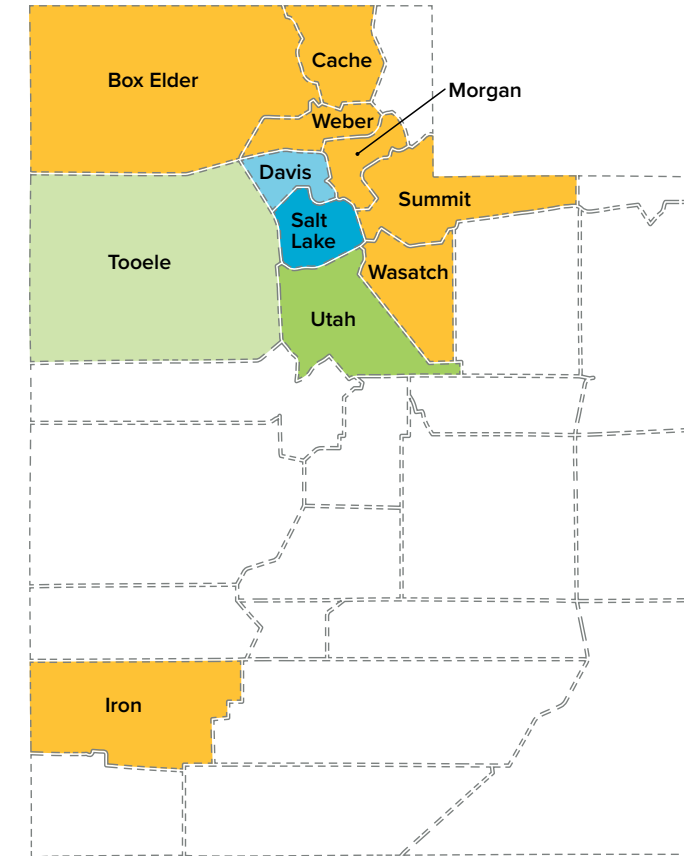
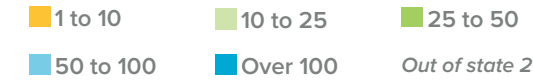
Emphasizes training children in skills such as emotional literacy, empathy or perspective taking, friendship skills, anger management, interpersonal problem-solving, school rules, and how to be successful at school.

TRAUMA-FOCUSED COGNITIVE BEHAVIORAL THERAPY (TF-CBT)

Post traumatic Stress Disorder (PTSD), depression, anxiety, externalizing behavior problems, relationship and attachment problems, school problems and cognitive problems. Includes skills for regulating affect, behavior, thoughts and relationships, trauma processing, and enhancing safety, trust, parenting skills, and family communication.

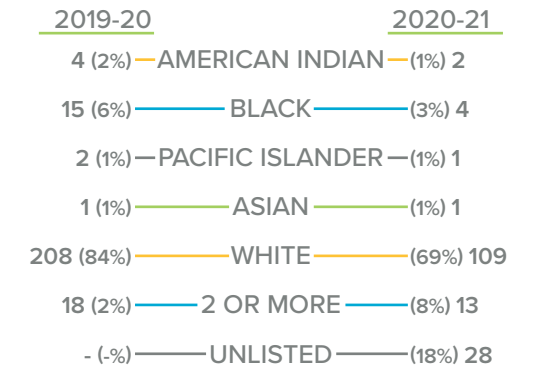


FAMILIES ENROLLED IN FAMILY THERAPY



THERAPEUTIC PRESCHOOL DEMOGRAPHICS

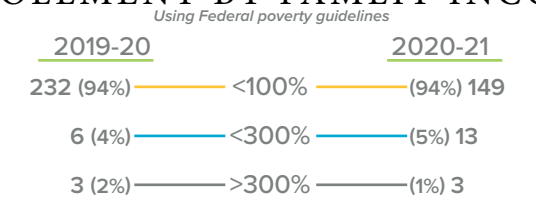
ENROLLMENT BY RACE*



ENROLLMENT BY ETHNICITY

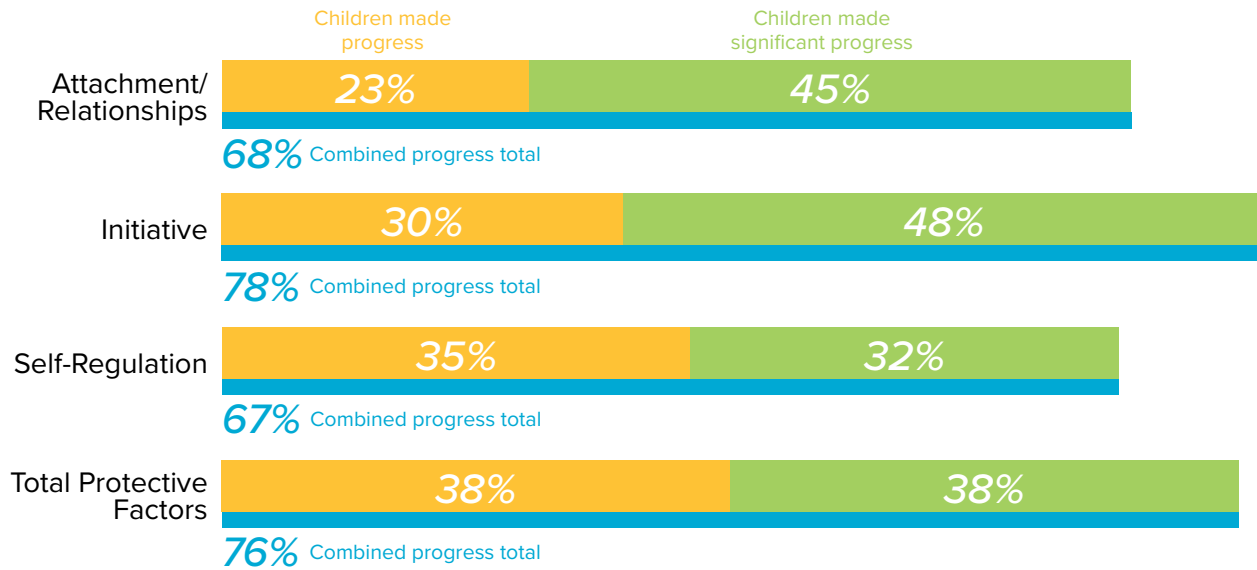


ENROLLMENT BY FAMILY INCOME*

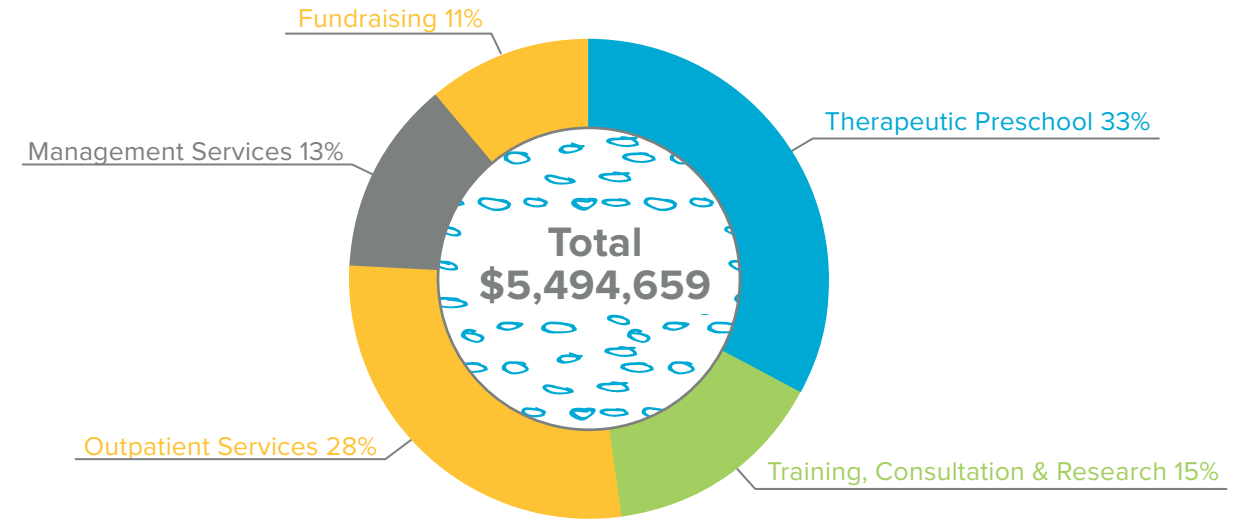

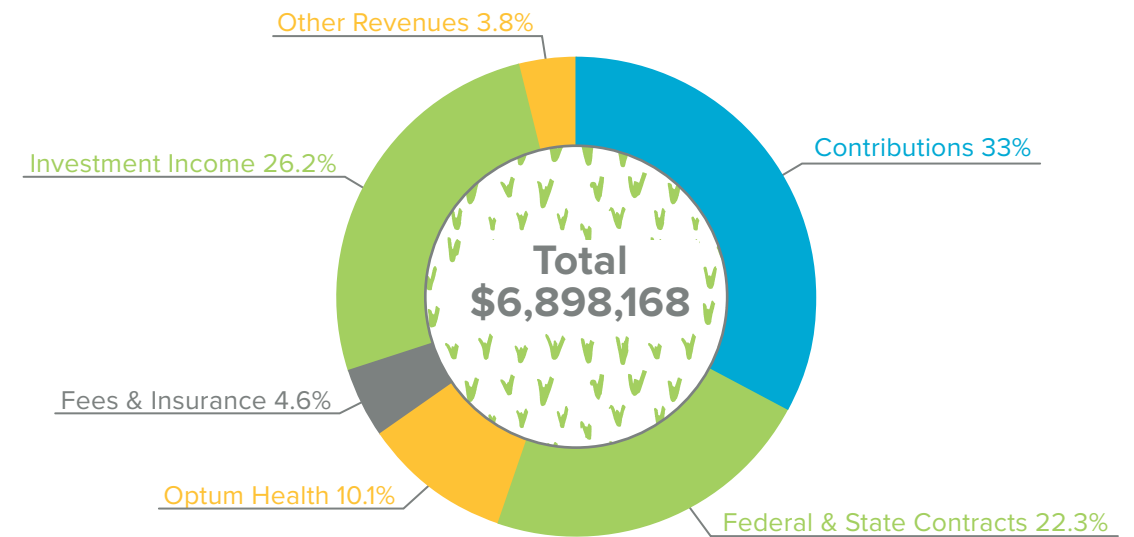

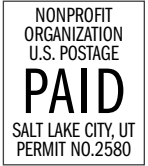
